Jasper County Pensions

Newton Journal, November 21, 1883

Below will be found a list of the brave men from Jasper County, who for heroic deeds on the battle field, from injuries received on the wearied march, or from diseases contracted in the prison pens, or from honorable services, are now receiving pensions from the Government. We received it from Washington and it is taken from the original documents now on file in the Pension Department, and as it will appear in the forthcoming work to be issued by the Government. It is not in all cases correct, as we have found some of the names wrongly spelled, and have in two or three instances corrected them when we know them to be wrong. Other errors may also be in the list.

(Gleaner editor's note: a number of unknown abbreviations were used for the cause and I chose to type it as found rather than interpret it wrongly.)

 - Read the sale notice of Mr. J. H. Janeway in this issue. Mr. Janeway is selling out with a view to emigrating to Kansas, early in the spring.
 - Mr. O. G. Sloan, of Buena Vista township, departed Wednesday for Hastings, NE, where he will locate. Mr. Sloan is a young man of excellent character and we bespeak for him a bright future.
 - Dr Hammer extracted a large fragment of a pin from the left leg of Mrs. C. Gage on Wednesday. This pin had been swallowed by Mrs. Gage thirteen years ago. While using this pin to clean wax from her ear, she accidentally let it drop into the ear, but supposed at the time that it had fallen on the floor, but while riding in a wagon a short time thereafter the pin dropped into the back of her mouth and she swallowed it. Her health was affected for some years thereafter. It was taken out near the ankle (reprinted from the Iowa State Democrat).

The library is open every Thursday and Friday 10:00 am to noon and 1:00 to 3:00 pm and from 9:00 am to noon on the first and third Saturday of the month. There is no charge for using the library.


