Bush Lamb "Missing" In North Africa Former Newton High and Iowa U. Star Athlete Reported 'Missing In Action'



Tall, rangy popular Lieut. L. Bushnell (Bush) Lamb, one of Newton high school's athletic greats, today became the first Jasper county man "missing in action" on the North African front, according to word received by his wife, Dorothy Al. Smith Lamb of Clinton, Ia.

Mrs. Lamb, a niece of Mrs. N. E. Molleck of this city, received the message from the war department the day before Thanksgiving at her home in Clinton where she is serving as executive secretary of the Clinton county Red Cross chapter. Clinton is her home.

Mrs. Lamb has received no further word since the first "missing in action" message. Lieutenant Lamb was presumed to have been participating in the North African campaign, in action at the front. He was pilot of a medium bomber. Mrs. Lamb also, reported that the husband of a close friend of hers was with Lieutenant Lamb at the time and is also reported missing.

Maybe Forced Down

Local relatives held to the belief that his plane might have been forced down somewhere in North Africa and that he may be a prisoner of war, or "on his own" in the North African wastes.

Lieutenant Lamb was in Newton last spring to attend the funeral of his mother, the late Mrs. Price Lamb and again in July for a short time.

A few weeks ago, relatives here said that he flew his plane over Newton, reroute east, possibly then heading for the North African front.

Lamb was an outstanding athlete in Newton high school, starring in football, basketball and track. He gained statewide prominence as a hurdler in high school days and was a star on the Newton football and basketball teams. One of his major football accomplishments was piloting the Newton team to a 12 to 7 victory over Grinnell in 1932 to break the "Grinnell jinx" that prevailed for 20 years.

He was graduated from Newton in 1935 and then went to Iowa University where he starred as a backfield player on the Hawkeye elevens of 1936, 1937 and 1938. He also played basketball there and won the Big Ten javelin throwing championship two years.

His father, Price Lamb is now living in California with a brother Gerald Lamb near Los Angeles. Other members of the family are a brother John Lamb of Greenfield, Ia., three sisters, Mrs. Loren Altemeier of north of Newton and Mrs. DeLocas Trout and Mrs. Roy Teeper of Des Moines.

Bush Lamb is Listed Missing

Washington – (AP) Lieut. Laird B. (Bush) Lamb, formerly of Newton, ia., today was announced by the U.S. war department as one of 20 Iowans missing action. Lieutenant Lamb was listed as missing in North African action.

Lieutenant Lamb, known as "Bush" in Newton where he starred in high school athletics and later at the State University of Iowa, was first reported missing last November when his wife, Dorothy Smith Lamb of Clinton, Ia., received word from the war department. Since then no further word has been received from him, the announcement by the war department merely confirming its previous message to Mrs. Lamb

(Lieutenant Lamb's father is Price M. Lamb of Greenfield, Ia. His wife, the former Dorothy Smith is a Red Cross executive.)

Editor's Note: Lieut. Lamb nor his plane was ever found.

9,516 Are Registered In County

Total of Men Registered Under Selective Service Covers 6 Registrations

A total of 9,516 Jasper county men are now registered under the various selective service divisions, a report by the county selective service board showed today.

This total has been registered in six registrations held since the selective service act was made a law in September of 1940.

Helming Missing, Not Killed As First Reported (Special to the Daily News)

COLFAX – Relatives here of Lloyd Helming, 23, aviation machinist mate, first class, and a former resident of this community were brightened today by the report that the last word received from U.S. navy department officials was to the effect that he is "missing in action" in the Pacific theater, not killed as previously reported. The killed in action report was received Monday here amid a series of conflicting reports of a patrol bomber crash in which he was involved.

The navy department has not issued any word that he was killed or that he was lost at sea. The latest word sent out is to the effect that his is missing.

In view of the fact that sailors are often missing for many days following a mishap before they are found at sea or on a small island, relatives and friends today were highly hopeful of his safety.

Helming, whose parents now live in Des Moines, has been in the navy for five years. He visited in Colfax last September, his first trip back since he entered the service. He is a native of Baxter, Ia.

Lieut. Deierling Writes From "Somewhere in Africa"

Lieut. Fred Deierling, former manager of the J. C. Penny shoe department in the store here, was in one of the large battles in the invasion of Northern Africa, according to messages received here.

Deierling, although he was unable to give his location, said that he was in a 72-hour battle in which they finally took the beachhead and made the landing. The first message was written before the invasion, while he was still on board the ship, but, aware of the invasion plans, said that by the time the letter arrived in Newton, which was around Dec. 1, they hoped to have control of the Northwestern part of Africa.

Later messages stated that they were camped on a hill, overlooking the ocean, and everything was quiet. Turkey was the main dish for Christmas dinner, which was welcomed since they had been living from canned rations, with little fresh foods except what they secured from the natives.

Deierling received his basic training at Camp Wolters, Texas, after he enlisted Oct. 22, 1941. He was then promoted to Corporal and went to officer's candidate school at Fort Benning, Ga., where he was commissioned a lieutenant Aug. 21, 1942.

He was later stationed in Ireland and now is in Africa. His address is Lieut. Fred Deierling, care of Postmaster, Fort Bragg, N.C., A. P. O. 9.

Newton Pilot Is In Crew of Bomber Six, Five of Whom Bail Out



First Lt. Morris W. Kautz, a Newton veteran of air bombing missions operating from English bases, has been "missing" in action over Belgium since May 7," according to word received Saturday by his mother, Mrs. Adolph Kautz of Altoona, Ia., formerly of this city.

Today Mrs. Kautz received a letter from her son's commanding officer stating that men on an accompanying bomber on the same mission,

witnessed five of the crew of six men of the ship of which Lt. Kautz was a pilot, bail out in parachutes.

Lt. Kautz had previously been cited in dispatches from the European area for his bravery and his alertness in action for which he has been decorated with the Air Medal with seven oak leaf clusters and the Distinguished Flying Cross. Kautz pilots a Martin Marauder.

According to the last letter received from him, written May 4, he had completed over 45 missions and had recently had a two-week leave to Scotland for rest.

Note: Morris Kautz was a Prisoner of War in Germany until the end of the war. He died in 2000 and was buried in Arlington National Cemetery in 2002.

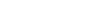


