Know Ye, That, whereas, Eugenia Haley late of Warren County, Iowa, died intestate on or about the 6th day of May 1916 having at the time of her decease, personal property in this State, which may be lost, destroyed or diminished in value, if speedy care be not taken of the same. To this end, therefore, that said property may be collected and preserved, and administered upon us as by law required, the District Court of Warren County does hereby appoint and commission George Aller as Administrator of all and singular the Goods, Chattels, Rights, Credits and Effects which belonged to said decedent at the time of her decease, with full power and authority to secure and collect the said property and debts, wheresoever the same may be found in this State, and in general to do and perform all other acts which now or hereafter may be required of him by law.

In Testimony Whereof, I have hereunto set my hand and caused the seal of said Court to be affixed at Indianola, this 25th day of May, 1916.
