J. B. Patterson received a telegram this morning announcing the death of Mrs. Patterson's brother, Phillip Hull, at Orilla, Warren County, Iowa. The deceased was an early settler in Boone county, coming here in 1850. His home was seven miles south of Boone, where he resided for twenty years. The funeral will be held Wednesday of this week at Orilla. Mr. Patterson will attend the funeral but Mrs. Patterson is prevented from going on account of bad health.

Philip Hull, a former Boone county resident, died at his home in Orilla, Warren county, Iowa, Monday. Mr. Hull was an old settler in this county, coming here in 1850. J. B. Patterson received a telegram on Monday morning announcing the death of Mrs. Patterson's brother, Philip Hull, at Orilla, Warren County, Iowa.

The deceased was one of the earliest settlers in Boone County coming here in the year of 1850 and made his home about seven miles west of this city where he resided for over 20 years moving to Orilla from there a few years ago.

The funeral was held yesterday at his home. Mr. Patterson was in attendance but on account of illness Mrs. Patterson was obliged to remain at home.

Know all men by these presents:

That I, Philip Hull of the Village of Orillia, County of Warren and State of Iowa, being of sound mind and memory - do make and declare this to be my last Will and Testament, as follows to wit:

First – My will is that at my death or as soon thereafter as possible that all my just debts, if there be any, be paid from the sale of the grain that is now on my farm.

Second – My son Judd Hull having received of me heretofore the sum of five hundred (\$500) dollars cash. I now in addition to said sum will and bequeath to him the North Eighty (80) acres of my farm, the same being and situated in Lincoln County Kansas.

Third – I will and bequeath to my daughter Nett (Mrs. T. J. McLain) the sum of seven hundred (\$700) dollars, said sum to be paid out of my life insurance policy, and to be paid to her within ninety (90) after its collection from the Insurance Company.

Fourth – My son Byron Hull having received of me heretofore the sum of five hundred (\$500) dollars in cash. I now in addition to said sum, will and bequeath to him the sum of one thousand (\$1000) dollars, and that said sum be paid to him at the time of his marriage, and that said sum be held by my administrator until the date of his marriage, and in case that he does not marry, the said sum shall be used and held as a permanent fund in supporting him in his old age, the same and aforesaid bequest of one thousand dollars is to be paid to my son Byron out of the note of two thousand dollars that I hold against my son Bert D. Hull.

Fifth – My son Finley Hull having heretofore received of me the sum of five hundred (\$500) dollars in cash. I now in addition to said sum, will and bequeath to him the South Eighty (80) acres of my farm located, being, and situated in Lincoln County Kansas.

Sixeth – I will and bequeath to my daughter Rosa (Mrs. H. E. Beeks) the sum of seven hundred (\$700) dollars and that the said sum be paid from the proceeds of the sale of the South West forty (40) acres of my farm which is situated in Section Nine (9) in 77 N. R. 25, Linn Twp., Warren County, Iowa, and my will is that the said above mentioned forth (40) acres be not sold for less than (\$40) dollars per acre.

Seveneth – My son Bert D. Hull having heretofore received of me the sum of three hundred (\$300 dollars, I now in addition to said sum, will and bequeath to him the sum of six hundred (\$600) dollars, and that said sum be paid to him, by him being allowed to keep and retain the amount from the note of two thousand (\$2000) dollars that I hold against him, and that is previously mentioned in paragraph fourth herein.

Eighth – My son Walter Hull having heretofore received of me a quarter section of land in Northern Iowa, and also the sum of three hundred and fifty (\$350) dollars in cash. I now will and bequeath the sum of twenty (\$20) dollars.

Ninth – I will and bequeath to my daughter May (Mrs. F. S. Johnson) the sum of seven hundred (\$700) dollars, said sum to be paid to her from the sale of my lower south west forty (40) acres in Linn Twp., Warren County Iowa

Tenth - I will and bequeath to my daughter Blanche Hull the piano, the sewing machine, one horse and one cow a set of dishes and two years schooling and the expenses of schooling to be paid from the sale of what personal property that may remain. I also give and bequeath to her the sum of seven hundred (\$700) dollars.

Eleveneth - I give and bequeath to my grandson Ross Philip McLain the sum of fifty (\$50) dollars said sum to be given to him when he is eighteen years of age.

Twelfth - I give and bequeath to my grandson Philip Theodore Beeks the sum of fifty (50) dollars and that said sum be given to him when he is twelve (12) years of age.

Thirteenth – Lastly, I now nominate and appoint my son Bert D. Hull to be the executor of this my last will and testament and that he shall serve as such without being required to give bonds.
