Zachery Lay, who lived four miles west of here, died very suddenly last Friday night. He worked in the corn field the day previous, retired well as usual and died before morning. Dr. Welty was called but life had fled before he arrived. He says he died with heart disease. Mr. Lay was about 65 years of age, an old settler here and member of "The Friends" church; he was an honest man, a good neighbor and respected by all. Witness our hands this 27th day of May 1885.

The Condition of the above obligation is such, that whereas, the above named J. M. Garrett under the last Will and Testament of Zachaheus Lea and on petition of widow was by the court appointed to execute the last Will and Testament as aforesaid according to the tenor and effect thereof.

Now if the aforesaid J. M. Garrett shall discharge all and singular my duties as such Executor and at all times render a true account of his doings in the above premises whenever thereto required by law, and do all things which are or may be hereafter required of him by law, then these presents to be void, and otherwise to be and remain in full force and virtue in law.
