
Friends of the Bloomfield Library

Floris, Lick Creek Township, Davis County, Iowa

Township 70, Range 13, consisting of 22,418 Acres. Post Office Floris. At one time was composed of Nine school districts. With the first school house being built on section 29 in 1847, by Jerry Stark. First death ¹ Mother Jones, mother of Michael Jones, who died in 1844, and was buried on Soap Creek, north of Floris, in Peytons burying ground. [UnMarked]. The first female child born was a daughter of Mike Jones, born in 1844.

The Order participates and observes in Memorial Day, seeks and marks the graves of Civil War veterans; ensures that signage along US Route 6, the GAR highway, is maintained. The SUVCW supplies scholarships, funding and ceremonies, along

with parades and grants, for Civil War Memorials. Meetings and Encampments are conducted according to tradition of the GAR.

Membership is open to male descendants of soldiers, sailors, or marines. The application fee and annual dues vary from on Camp to another.



Sowa Battle Flag Monthly Report

VOLUNTEER NEWSLETTER

Flag History 2001.71.72 2nd Iowa Infantry, National

The ladies of Bloomfield presented this national flag to the 2nd Iowa Volunteer Infantry, Co. G during April 1861. The 2nd Iowa was raised in Davis County and was the first regiment to leave the state for the front. This flag went through the entire war starting in April 1861 and remained with them until July 12, 1865. The soldiers of the regiment proudly carried this flag in their knapsack in every battle, and skirmish on every march. It was at Fort Donelson when the 2nd Iowa made their desperate charge and planted the Stars and Stripes upon the heights of the fort, when it was found that the regiment's flag was so badly



shot to pieces that it could not longer be used. Co. G. agreed to loan the above flag to serve as the regimental colors until a new flag was drawn.

In all the marching and fighting over four years the flag was with the company. It was at Shiloh with the Co. when the regiment cut its way out of the "Hornets Nest." It was at the Siege of Corinth, Battle of Bear Creek, Battle of Resaca, Battle of Rome Cross-Roads, Battle of Dallas, Battle of Kennesaw Mountain, Battle of Nick-a-jack Creek, Siege of Atlanta, Battle of Atlanta, Advance on Jonesboro, Battle of Eden Station, Battle of Little Ogeechee, Battle of Columbia, and Battle of Bentonsville and with the Co. on the grand review in Washington, D. C. at the close of the war.

The flag was with the Co. when it marched with Sherman to the sea. It was along when Co. G. made their peculiar record of fighting a battle in "their birthday uniforms". The naked advance guard wading Lynch's Creek, S. C., as skirmishers were attacked by rebel cavalry.

The flag continued to serve the regiment and the men of Co. G after re-enlistment. Earning a thirty day furlough the men of Co. G brought the flag to Bloomfield presenting it to the women who made it. The women, though honored, sent the flag back into service with the men.

Newspaper accounts from April 1861 quote a Miss Mattie Hagan, who presented the flag to the Co, as saying "Captain Baker in behalf of the ladies of Bloomfield allow me to present to you and your company this beautiful flag. You go forth to protect it and the honor of our country, we stay at home to assist you with our words of encouragement and our prayers. Take it Captain and protect it until it waves over every foot of American soil."

Captain Baker is quoted as saying "Ladies, in behalf of the Co., which I have the honor to command, permit me to accept this beautiful flag, assuring you it's bright folds shall never be sullied by any act of ours. We take it and promise to define it as long as there is an arm left of wield a weapon in its defense." Upon handing the flag to 2nd Sergeant J. M. Duffield, Captain Baker called for the men of the Co. to give a shout of cheer to the ladies of Bloomfield. "Hip, hip, hip, hurrah, hurrah, hurrah."



- 1. Each exhibit **MUST** have attached an explanation of genealogical connection of why it is important to the exhibitor including exhibitor's name and address. Please use the 5 W/s in the explanation. Who, What Where When and Why. Information needs to
 - 5 W's in the explanation, Who, What, Where, When, and Why. Information needs to show relationship and be understandable as a stand alone exhibit by anyone reading it.
- 2. Suggest use of sheet protectors or sandwich type bags for protection; lamination is not recommended.
- Original documents are discouraged, computer generated or photocopies will be accepted and need not be framed or matted.
- 4. NO entries will be accepted by mail.
- 5. No more than 1 entry per category per exhibitor, but may have 1 exhibit in each category listed.
- 6. Previous years first 3 placing items may not be re-exhibited. Those not placing may be re-exhibited.

Judging is based on the item as described in the category and the genealogical value of the item, not on the age or presentation. If entries don't qualify or are not an acceptable standard, placing may be withheld. Not responsible in case of loss. The Judge fees and premiums are paid by the Davis Co. Genealogical Society.

- 1. Pictorial Family History—poster or organized photo collection
- 2. Legal Document
 - a. Land grant, deed, mortgage, lien, etc pertaining to land
 - b. Military record, discharge papers, pension, etc.
 - c. Marriage, divorce, birth, death
- 3. Family Records—school, diary, letters, etc.
- 4. Family Religious—confirmation, baptism, Bible pages, etc.
- 5. Family Certificate/document-wedding certificates, organization memberships, etc
- 6. Pedigree/Ancestor-pyramid of parents in a direct line of an individual
- 7. Lineage—relationship between 2 people i.e. John F. Kennedy and Maria Shriver
- 8. Genealogical Record book

- 9. Research Material
- 10. Photo—2 people or less, wedding, graduation, etc
- 11. Photo—3 people or more of a family group
- 12. Photo–Ancestral building, home, school, church, business
- 13. True Story written by exhibitor not to exceed 1 typewritten page
- 14. Article from publication other than local with family connections
- 15. Storytelling display i.e. time line specific with photos
- 16. Photo depicting Davis Co. history...doesn't need to have family connection
- 17. A written Davis Co. History of at least 1 page—a church, school, place, building, event, etc with or without photos
- 18. Scrapbook collection of clippings, photos, keepsakes, etc NOT the new scrapbooking
- 19. Document or certificate relating to Davis Co. History does not have to relate to exhibitor
- 20. Display of 2 or more documents that are relevant to each other ie birth-death, marriage-divorce, enlistment-discharge, etc
- 21. Miscellaneous—if artifact, bring only photo and written facts as outlined above
