EF REEVES DEADS

of Bloomfield's Business Men Succumbs Saturday Morning.

Ed M. Reeves, for many years one of the prominent figures in the local business world, died at his home in Bloomfield early last Saturday morning after an illness that has confined him to his home for the past few months.

Mr. Reeves was a photographer and was probably known to more Davis countyans than the average business man of the town. He delighted in drollery and enjoyed nothing better than to imitate the peculiarities! of others, but never in a way to bring9 offense or criticism.

A few months ago, he was forced by illness to close his place of business and remain at home. His fellow citizens assumed that his place would be closed but a short time and that he would soon recuperate and again resume his work, but his condition grew steadily worse until the end came to relieve his suffering.

He leaves a wife and two children, Mrs. Verne Schlegel and little Miss Dorothy. One daughter preceded him in death.

The funeral was held at the home Monday, conducted by Rev. G. E. Purdy of Oskaloosa, formerly pastor of the local Christian church. Interment was made at the I. O. O. F. cemetery.

This agreement witneseth, that the Executrix of the estate of Ed M Reeves, Deceased, is pursuance of the order of waiver of appraisment of the personal effects of said estate, this executrix has sold and by these presents sell to J A Warner the photograph Gallery of which Ed M Reeves died seized, intending to transfer to said Warner all the furnishings and material owned by said Reeves at the time of his death. Possession of said Gallery is to be given to said Warner on this day February 10th 1919, and for the consideration of \$475.

This is the 9th year the Davis County Genealogy Society has sponsored a booth of exhibits. Judging, held by Jay DeYoung of New Sharon a person familiar with genealogy and history research. Thomas A. Dunlap Thomas A. Dunlap, sen of John and Elizabeth Dunlap, was born in Bedford county, Pennsylvania, May 16, 1841, and died at his home in

Bloomfield, lows, February 16, 1935, being 93 years and 9 months

He was the only son in a large family which grew to manhood; there were six sisters which grew womanhood established and: homes of their own.

Thomas came with his parents to Iowa, leaving the home in Pennsylvania, and coming down the Ohio river by boat, thence up the Mississippi river to Keokuk, Iowa, and from there on to Jefferson county where father Dunlap entered a farm from the government, near Salina, northeast of Fairfield. They had made the trip in a cov-ered wagon across the prairies from Keskuk. This was in about the year 1845, the same year that Iowa was made a state. Here Thomas grew to manhood, he had attended the country schools and later became a teacher in the county schools. Later he attended the young State University which soon was moved to Iowa City and be-came the great State University of

Then the great Civil War broke out between the states. He was not old enough to enlist against the will of his father, but when of age he enlisted early in the year of 1862 in Co. G. 30th Iowa Infantry. He was with Sherman in Georgia in the famous march to the sea and later in the great Vicksburg slege and campaign. When the war was ended, he returned, broken in health, he went out in the western states to rest and recuporate. He returned from the west and opened a photograph gallery in Bloomfield and was in continuons business in Bloomfield for 42 years.

On April 22, 1873, he was united in holy wedlock with Sarah Terrance Hedrick, of West Grove, Iowa. To bless their home came lows. To bless their home came four children, the oldest was a son, Ira O., who passed away in infancy; then the daughters, Maude and Lula, and a son, William. They made their home in Bloomfield and here his little family grew to manhood and womanhood, living in the same home location to which he howeth his holds and which he brought his bride and from which he passed into his heav enty home.

In early manhood he joined the Masonic order. He was recognized by his brothers of the order in an official way, having at times been Worshipful Master, and other sub-ordinate offices but being their secretary for over 25 years. He was one of the charter members of Friendship chapter of Eastern Star. He served as a member of the city ecuncil for a number of years and always maintained an active interest in civic affairs. He was a very active member of the G. A. R. and ir his passing he leaves but three active members of the old Civil War group—Hiram DeVault, Ben Armstrong and James England.

He united with the Methodist Episcopal church in Richwood, Jef-ferson county, Iowa, when he was 19 years old. Upon coming to Moomfield he made his church home in the Bloomfield church. He

served the church as class leader, Sunday school superintendent, trus-tee and collection steward, and as long as he was able he was never absent from his church duties. His first joy outside of his home was the interest in the church prosperity, for he gave of his time, effort and means to its local and general enterprises.

This unfailing interest continued.

until during the pastorate of Dr. Nethercut, when failing health and deafness became such a hindrance. that he gave up attending the church services. His age brought on his falling health until the end came peacefully on Saturday, February 16, 1985. He leaves to mourn, the entire church, the commendation of which munity, the fraternities of which he was a member and the immedi-ate loved ones of his family group. The daughter, Mrs. Edward R. Col-lins, with her husband, Edward R., and their son, Robert T.; the daughter, Mrs. William H. Wise-man, with her husband, William, and daughter, Louise, of Bloomfield, Iowa, and the one son, William T., and his wife, Kate, of Ottumwa. Also there are two sis-ters, Mrs. Adaline Harken, of Rich-land, Iowa, and Mrs. Bell Goss, of Harper, Kansas. The beloved wife passed away on September 23, 1925.

The passing of Father Dunlap is of more than passing interest to the entire church life of the city. His name was always associated with the movement of the Metho-dist church activities in Bloomfield. Every pastor soon come to know of Father Dunlap and early sought his counsel and advice.
When meeting another paster who
ever was associated with the Bloomfield church, one of the very first inquiries was of Eather Dun-lap. Outstanding has been the association of the present pastor, in the few visits to the home it ever been a benediction, of help and cheer. Dr. John W. Potter, a retired minister new, but one who served Bloomfield and often was in the home of the deceased, is a very close friend, having ministered unto them for a number of years and with them in the home life of the then young people in the home so fitting that he should bring the Christian message for the funeral service. God has crowned another of His saints.

Pioneer Passes Another Away.

A. S. Reeves, one of the eldest residents and citizens of this place died at his home in this city Monday morning. Me had been in a very crifical condition for several weeks and his death was not unexpected. He was in his eighty-third year. The funeral was conducted from the Universalist church Tuesday morning at nine o'clock.

The following obituary appeared in the Hawkeye:

A. S. Reeves, a well-known and highly respected pioneer settler of Davis county, died at the home of his son, Ed Reeves, in this city, Monday morning, July 15, 1901. The cause of his death was kidney trouble. Mr. Reeves was born at Marysville, Kentucky, August 4, 1818, moving with his parents, when a child, to Blocmington, Indiana. In 1836 he moved to Gosport, Indiana, where he began business for himself as a harness maker, came to Iowa in 1845, remained in the state a short time and returned to Indiana, where he stayed for three years, coming again to Iowa in 1848, and has been a resident of Bloomfield ever since. He was married twice. One child, Mrs. Flora Sauers, of Des Moines, is the only child living of the first marriage. To the second union six children were born, all boys, two of whom are still living, Ed and Sherman, photographers of this city. 1901

Michael Toops 1825-1900, bd Inskeep Cemetery: married Nancy Spencer and their daughter Mary A born 11-24-1854 Indiana, married Charles Inskeep, 19 February 1874.

William Toops married Elizabeth Little in Clark County, MO; 4 February 1883.
